- A quick review of the difference in the Application for Absentee by Mail as opposed to past Elections. Press Release has been submitted.
 - IMPORTANT INFORMATION FOR ELDERLY AND IDSABLED VOTERS REQUESTING AN ABSENTEE BALLOT BY MAIL: ***Please phone our office should you have any questions. *** Per the Georgia Secretary of State Elections Division: Voters who are elderly and disabled are normally entitled to make one absentee application, which rolls over to all elections in the cycle. However, for any special primary, special primary runoff, special election, or special election runoff; voters in this category are required to file separate and distinct applications for an absentee ballot. Any elderly and disabled voter as described in O.C.G.A § 21-2-381 (a) (1) (G), and SEB Rule 183-1-14-.01 (1) and (2) will have to request and absentee ballot for the special primary on June 17th, possible special primary runoff on July 15th, special election on November 4th, and possible special election on December 2nd. James Newland asked what age a voter is considered elderly at. Kim Slaughter replied at the age of 65 and up.

Financial Update:

- Kim Slaughter met with the Board of Commissioners on April 2nd, 2025 and answered any questions concerning the FY 2026 Fiscal Budget.
- A conversation took place about the renovation of the newly acquired office space. It is the majority of the Board of Commissioners and the County Administration consensus to have the renovation completed prior to the May Gubernatorial Primary Election to be held next year.
- Since learning of the results of the qualifying held for Public Service Commission, there will be an addition to the line item of Election Expense for the very possible July 15th, 2025, Primary Runoff. Mrs. Slaughter has contacted Assistant County Manager Erica Dye and informed her of this addition.
- A financial printout was given to the Board members. Balance to date is \$42,182.33. Mrs. Slaughter reminded the Board that two line items were added to the FY Budget 2025 which was unexpected. Request for amendment to the FY 2025 Budget for the estimated cost of the June 2025 Special Primary has been sent to the County Administration for the approval of \$72,897.00.
