 - IMPORTANT INFORMATION FOR ELDERLY AND DISABLED VOTERS REQUESTING AN ABSENTEE BALLOT BY MAIL: ***Please phone our office should you have any questions. **** Per the Georgia Secretary of State Elections Division: Voters who are elderly and disabled are normally entitled to make one absentee application, which rolls over to all elections in the cycle. However, for any special primary, special primary runoff, special election, or special election runoff; voters in this category are required to file separate and distinct applications for an absentee ballot. Any elderly and disabled voter as described in O.C.G.A. § 21-2-381 (a)(1)(G), and SEB Rule 183-1-14-.01 (1) and (2) will have to request an absentee ballot for the special primary on June 17th, possible special primary runoff on July 15th, special election on November 4th, and possible special election on December 2nd.
