Office of Elections and Voter Registration announces important information regarding the upcoming November 5, 2024 General Election.

- October 7, 2024 Mailing out of Absentee Ballots began.
- Advance(Early) Voting Dates: (Begins on a TUESDAY for this Election).

October 15-19, 2024 from 8 a.m. until 6:00 p.m. (Tuesday – Saturday)
October 21-26, 2024 from 8 a.m. until 6:00 p.m. (Monday – Saturday)
October 28 – November 1, 2024 from 8 a.m. until 6 p.m. (Monday – Friday)

Advance (Early) Voting will take place at the **Office of Elections and Voter Registration**, **825 Memorial Dr.**, **Griffin, GA 30223**.

- October 25, 2024 The last day to request an Absentee Ballot by mail.
- November 5, 2024 ELECTION DAY (All 17 precincts will be open from 7:00 a.m. to 7:00 p.m.)

Logic and Accuracy Testing: Logic and Accuracy is the testing of all election equipment to be utilized in the November 5, 2024 General Election. Testing began on September 19, 2024 and commences daily (Monday through Friday), from 9:00 a.m. to 4:00 p.m., and will continue until testing is complete. The Logic and Accuracy testing site is located at 825 Memorial Drive, Griffin, GA 30223.

<u>Drop Box Location for Absentee Ballots:</u> Absentee ballots may be dropped off inside the Office of Elections and Voter Registration office located at 825 Memorial Drive, Griffin, GA 30223. The camera secured drop box is available, as required by law, from 8:00 a.m. to 6:00 p.m., during the hours and dates of Advance (Early) Voting. (Please note the above dates and times.)
