 - Member Dexter Wimbish Being proactive in minimizing confusion by having a special Citizen Comment Session where citizens can come and voice their opinion for three minutes.
 - o Member Chris Piland Requested a timeline with key milestones and objectives as well.
 - Chairman Ben Johnson November 10, 2025, at 6:00 pm the Citizen Comment Session will be held regarding the Precinct Consolidation.
 - Chairman Ben Johnson December 9, 2025, The Board will vote on whether to pass the precinct consolidation proposal or not.
