The Regular Monthly meeting of the Spalding County Board of Elections and Voter Registration was held at the Spalding County Courthouse Annex at 119 E Solomon St. Room 108 Griffin, GA 30223 at 6:00 p.m. on Tuesday, October 14, 2025. **Advance Voting** - 196 Voters have cast their vote early on the first day of Advance Voting.

### **Precinct Consolidation -**

- Timeline:
  - Request to change meeting for public comment from November 10, 2025 at 6:00 p.m. to January 13, 2026 6:00 p.m.
  - If the Precinct consolidation is passed, data entry will begin next day.
  - Precinct notifications will be mailed out no later than January 30, 2026
- There was discussion - Discussion was held between Board members and the Election Director about the request to change the meeting for public comment. Board member Lee Howell shared that he thought that there should be a month in between public comments on the precinct consolidation proposal and the scheduling of the vote. Director Slaughter shared that the Board entrusted her to do the job she was hired to do and that her responsibility is to the Staff and to the voters of Spalding County. She also shared that if the proposal were to pass, the office had work to process with the voter registration system and afterwards to notify all voters who would be affected by the consolidation. She shared that signs would need to be made for all locations involved as the law mandates. She included also that there was not any need to wait a full month until voting on this issue when the proposal has been presented to the Board and has been a subject of conversation for at least four months. She also reminded the Board that there had been two consolidations of Precincts brought before the Board in the past. And Board members at that

time did not select to have a meeting specific to public comment. Board Members Chris Piland, Vice Chair James Newland, along with Chairman Ben Johnson were all in agreement that the Board should be prepared to vote on the Precinct consolidation the night of Public comment, which is to be held on January 13, 2026 at 6:00 p.m. It was determined that the decision to approve or not approve be made immediately post hearing taking into consideration the public comments made.

**Remodeling of newly acquired space:** Director Slaughter will continue to work with LJA along with the floor plans for the newly acquired workspace. This is a work in progress.
