**Voter Registration Update: Sandra Hardy** - (Total number of Registered Voters as of March 10, 2026 – 53,343.)

**Summary of Processed files:**

- New Voters – 252
- Transfers into County - 271
- Address Change - 261



- **Remodeling of newly acquired space:**

- Next Monday evening, there should be a request to go before the BOC to approve a \$73,000 request for the architectural firm's bid. Once that is approved, the architect will begin work to finalize the plan and prepare the documents to bid for work for renovation.

- **Precinct Consolidation:**

- 100% of consolidation processing has been completed and all voters affected have been updated within the GARVIS system.
- 100% of affected voters have been contacted via mailed correspondence.
- 50,783 voters were affected by some type of related change.
- It's important to note that 21,625 voters did not move locations but were affected by a "precinct number change" only.
- We are required by law to notify voters of any changes.
- Complaints/Concerns received about the Precinct Consolidation:
  - 2 complaints for the traveling distance from Faith Baptist Church to Union Baptist Church. (1) of these not really upset just working out their concern.
  - 1 visitor to the office yesterday to complain that the precinct consolidation was a form of Voter suppression. This voter's record reflected the use of Absentee by Mail for her voting record. We assured the voter that this was not a form of voter suppression and that it would in no way affect how she cast her absentee ballot by mail. After having an open dialogue with the voter, she was fine when she left our office.
- Signage will be placed at each old and new polling location for voters who are affected by the change.

- GAVREO Conference will be attended by three staff members from March 22 to March 25, 2026
- Poll Officer Training Dates have been set beginning on April 7<sup>th</sup> and ending on April 23<sup>rd</sup>, and the process of poll officer assignments and equipment assignments have begun.
