## **Election Director Report –**

### a. Report by Elections Director

- Two complaints were received out of the 6,345 voters that cast their ballot on election day concerning wait time and one additional complaint came from a State Democratic Poll Watcher concerning wait time as well as more equipment needed. Most voters arrived after 3:00 and compounded with the length of the ballot it took some voters over 30 minutes to cast their ballot. We did try to educate our voters beforehand. Chairman Ben Johnson wants us to track everything and make sure we are well equipped.
- We have received the proofs for the June election and have already reviewed the first set of proofs. There will be six contests on the Republican ballot and four on the Democrat ballot.
- Logic and Accuracy Testing is set to begin on June 2, 2026.
- Advance Voting will begin June 8, 2026 on Monday and continue through that Friday.
- This week we will be conducting the ballot image audit as well as the State and Board mandated audits on Friday.

Chris Piland requested to see a staffing model under the 19 precincts (including AV) vs now with the 9 precincts (including AV) to include staff and equipment.

Board members also requested a list of items that they could write to the SOS and try to get them to respond in getting these items handled.

## **Board Members Comments –**

- **Chris Piland** – Advised great job by staff but believes we did see impact to the smaller precincts with the new amount of equipment. On election night, they did not start getting to the office until 9:00 p.m. Director Kim Slaughter did advise that she would like to have a set up and break-down team that would assist the precincts with this job.
- **Dexter Wimbish** – Said that a 45 minute wait is not something to complain about when there are countries around the world where people still don't get to vote or line up for days to vote. He stated Kim and staff did a great job especially since we did the consolidation just a couple months ago and only received 3 complaints. This is a testament to the work Kim and her staff have done and he appreciates it. We have come a long way.
- **James Newland** – Thinks the election went very well. He thanked the staff. Advised 45 minutes is not that bad, but we want to do better than that. If everyone is going to show up at the same time there isn't anything we can do. He understands this was the max time. When he went around to the polls around lunch time there were only 2 or 3 people in line so the lines were a lot shorter.
- **Chairman Ben Johnson** – Kim and everyone working together has made this work. We are accomplishing this mission. It is ongoing and agrees with Dexter's comments.
